



Directions to the Hotel

From I-85 South: Use I-77 Exit 38 to go South (toward Columbia). After leaving I-85, exit ramp to I-77 South curves sharply to the left. Continue to I-77 Exit 5, Tyvola Road. Turn left at top of ramp. At first traffic light, turn right into Westpark Drive. Hotel is on the right, past the Hilton.

From I-77 North: Use I-77 Exit 5. At top of ramp, turn right into Westpark Drive. Hotel is on the right, past the Hilton.

From I-77 South: Use Exit 5, Tyvola Road. Turn left at top of ramp. At first traffic light, turn right into Westpark Drive. Hotel is on the right, past the Hilton.

From I-85 North: Use Exit 33; turn right on Billy Graham Parkway. Follow airport instructions.

Directions to UNCC

From Airport: Exit airport to Billy Graham Parkway (south). Continue to Tyvola Road Exit, and turn right at top of ramp. Follow Tyvola Road 3.5 miles, cross over I-77, and turn right at first traffic light into Westpark Drive. Hotel is on the right, past the Hilton.
